Frame consisting of an all-round rectangular steel edging with welded-on table legs made from round tubular steel, powdercoated with coloured epoxy resin. Table top made from melamine resin-coated chipboard with glued plastic edge.



Due to the great variation between models we have chosen the representative model 23011, EcoTable-R 76x65 cm with chipboard and plastic edge, height 76 cm, for the purposes of analysis. The packaging is not considered here because, as far as possible, we do without this. Reusable packing blankets made from 100% recycled materials are used to provide protection during transport.



Product lifecycle (material cycle):




Carbon footprint:

Electrical components have been registered by VS under WEEE reg. no. DE 45470288 or by our suppliers in accordance with the German law on electrical and electronic equipment.
