Design consisting of circular tubing, pressed against the rectangular aluminium tubing edge frame using a very strong edge connector made from a special alloy and screwed to it. All powder-coated. Table top with melamine resin-coated chipboard and continuous moulded polyurethane (PUR) safety edge.



Due to the great variation between models we have chosen the representative model 21012, LiteTable-AL 80x80 cm with chipboard and plastic edge, height 76 cm, for the purposes of analysis. The packaging is not considered here because, as far as possible, we do without this. Reusable packing blankets made from 100% recycled materials are used to provide protection during transport.


